Issuance of Domestic Straight Bonds (Green Bonds)

Central Japan Railway Company has determined today the terms and conditions with respect to the issuance of the eighty-ninth series of domestic straight bonds (green bonds) (the “Bonds”), as follows:

1. Name of the Bonds	Central Japan Railway Company 89 th Unsecured Straight Bonds (Green Bonds)
2. Aggregate Amount of the Bonds	¥10 billion
3. Term	20 years
4. Interest Rate	2.033% per annum
5. Issue Price	¥100 for each ¥100 in principal amount of Bonds
6. Payment Date	May 31, 2024
7. Redemption Date (Maturity)	May 31, 2044
8. External Evaluation	We have obtained an external evaluation (second opinion) that the Green Bond Framework which we developed for the issuance of the green bonds is in alignment with the Green Bond Principles 2021 and other matters from the Rating and Investment Information, Inc. (the “R&I”).
