Video Recording and Verification near Tokaido Shinkansen Platform Boarding and Alighting Areas for the Purpose of Safety Improvements

As part of our efforts to improve safety on platforms, we will record video at Shin-Yokohama Station and Nagoya Station as follows. The acquired video data of passengers will be used only for this verification, will be strictly managed, and will be deleted after the verification is completed. #### 1. Overview

(1) Details of the implementation

As part of our efforts to improve safety on platforms, cameras will be installed near some boarding and alighting areas on Tokaido Shinkansen platforms to record video. Using the captured video, we will analyze whether it is possible to detect situations such as passengers remaining between the platform screen doors and the train or passengers approaching to the train. By doing so, we aim to implement, in the future, a device equipped with a function that assists station staff in ensuring safety on the platform when train departs.

(2) Recording period

January 3, 2026 (Sat.) – December 31, 2026 (Thu.)

(3) Recording locations

On the Shin-Yokohama Station platform (a section of Platform 1) and the Nagoya Station platform (a section of Platform 16 and 17)




